The Artist hereby represents and warrants to the TWCC that: (a) the Artist is the sole owner of all right, title and interest in and to the Works; (b) the Artist is the sole author of the Works, which are wholly original to Artist; and (c) the Works do not and will not infringe upon or violate any statutory or common laws or any rights of third parties, including but not limited to any copyright, or other proprietary, property, privacy, personality or other right.
